

“ILR WIN A TRAEGER GRILL” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over.
3. Employees (and their immediate families) of the Promoter, Participating Stores and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. A participating store is any Local Liquor, Liquor Boss, Liquor & Co or Countrywide Liquor store in Australia that displays advertising materials for this promotion (each a **“Participating Store”**).
5. Entries into the promotion open 04/09/24 and close at 11:59pm AEST on 01/10/24 (**“Promotional Period”**).
6. To be eligible to enter, individuals must spend \$20 or more in a single transaction on any Jack Daniel’s products at a Participating Store during the Promotional Period (**“Qualifying Transaction”**).

 - Upload a copy of their Qualifying Transaction purchase receipt; and
